The phrase “Separation of Church and State” was never intended to keep Christian values out of the government's domain. To the contrary, the First Amendment stated that, “Congress shall make no law respecting and establishment of religion or prohibiting the free exercise thereof”. There was no mention of the words “Separation of Church and State”. The founding documents clearly show the intent was to prevent the government from establishing a single Christian denomination as the state religion, as was the case in England. The effort was to keep government from meddling in an individual’s personal beliefs, not to keep religious beliefs out of government (politics). Numerous times the courts confirmed these views.

In 1801, President Thomas Jefferson reassured the Danbury Baptists, in a letter, that all Christian religions would remain equal under the law in stating that “the First Amendment has erected a wall of separation between church and state”. This position was upheld by the Courts, Congress, the House and the Senate for years.

In 1947, the court (Everson v. Board of Education) cited 8 words out of Jefferson's letter, without context, “a wall of separation of church and state”.
